- (c) ** Direct export of horse(s) to "other country" is subject to the Jurisdiction(s) acceptance of the horse(s) and the necessary logistics/protocol arrangements.
- (d) Flights (or) quarantine stations may have a maximum capacity. Bookings will be on a first come first serve basis and as such owner(s) are urged to complete and return this Form as soon as possible to allow ample time for the necessary pre export preparations.
- (e) Any incurred charges prior to the export date of the horse(s) shall be borne by the Owner(s).
- (f) Horse(s) are exported at owner's own risk.
- (g) Owner(s) may wish to insure their horse(s) for Transit insurance and shall be responsible for the premium.
- (h) Under the Club's "Horse Transportation Subsidy Program", owner(s) will be reimbursed a maximum of HKD200,000 of the actual freight costs to abroad countries and a maximum of HKD30,000 to the designated location within Mainland China. Owner(s) shall be responsible any additional charges that shall incur for the transportation process.
